

Motor Delays could be a sign of Neuromuscular Disease¹



Developmental Delay, Do a CK*



Cannot walk up stairs by approximately **24 months²**



Cannot jump with both feet by approximately **30 months^{2,3}**



Cannot hop on one foot by approximately **48 months⁴**



of children with DMD are **≤3 years old** when symptoms begin⁵

The AAP recommends a development screening at the 30 month well-child visit:⁶ if signs of developmental delays are identified, a CK test is recommended^{4,7,8}

*CK = creatine kinase.
